Sec. 2254. The issue on appeal is whether the record before the Ohio court that heard petitioner's post-conviction appeal shows that petitioner had cause for failure to perfect his appeal on the basis of the denial of his request for trial transcripts. We affirm the judgment of the District Court. I. 6 On November 9, 1977, petitioner was convicted of the robbery and rape of a woman who was shot and killed during the attack. He was sentenced to death on October 10, 1978. On October 31, 1978, petitioner's court-appointed appellate counsel filed a brief in the Ohio Court of Appeals raising three assignments of error. On November 7, 1978, petitioner's counsel received from the court reporter a copy of the record of a December 8, 1977 trial and the transcript of the December 11, 1977 pretrial motions. Petitioner's counsel apparently was not given a copy of the pre-trial hearing transcript. On November 13, 1978, petitioner's counsel filed a supplemental brief in the Ohio Court of Appeals raising three additional issues. On December 10, 1978, the Ohio Court of Appeals
